Karen,

I conducted the initial site visit in regards to the bald eagle on March 6, 2019. Correspondence and photographs regarding that site visit are attached. Additional site visits were conducted as part of the wetland delineation and overall ecological site reconnaissance (April 3-5, and 11-12, 2019). No bald eagle nests were observed during the ecological site reconnaissance. An agency site was conducted with the NYSDEC (Trevor Brady) and USACE (Andy Dangler) on May 13, 2019. During the agency site visit, the location of the previous nest tree was field reviewed with the NYSDEC and USACE. A subsequent e-mail summarizing potential site concerns following the May 13, 2019 site visit was initially provided by the NYSDEC on June 7, 2019, and is also attached. A later communication from the NYSDEC (Mike Clark) was provided on September 30, 2019 in specific regards to odonates.

I reached out to Trevor Brady and he said his review in 2019 focused on potential impacts to the Hudson River. Trevor recalled that Paul Novak (now retired) may have provided some information about the eagle nest tree but he wasn't able to join for the 2019 field visit. Thank you for circulating the final meeting minutes. Per Action Item 6d, NYSDEC staff offer the following additional information pertaining to bald eagle nests:

- There was one nest that was located within the project boundary, however, that nest fell in 2017. Even though the nest fell, the tree that it was constructed in is protected for 5 years (or until 2022). Please contact me if more information is needed on the location of this nest tree.
- There are multiple bald eagle nests in the vicinity of the project site, at a distance greater than 0.25 miles from the project site boundary. NYSDEC staff are not concerned with the potential for impacts to these nests given the distance from the project site boundary. However, the Hudson River is very active and provides great habitat for eagles. This means it is very possible for new eagle nests to be constructed within the project site boundary or within close proximity to the project site boundary in the future. As such, there could be a requirement for "time of year restrictions" during construction if new nests are established on or in close vicinity to the project site.
