### 1. INTRODUCTION AND OBJECTIVES OF THE PUBLIC PARTICIPATION PLAN

This Public Participation Plan (PPP) has been prepared by the Albany Port District Commission to aid in informing and involving the Ezra Prentice and South End Community about the Albany Port District Commission Marmen-Welcon Offshore Wind Tower Manufacturing Plant Project.

The objective of this PPP is to promote communication and to assist the Ezra Prentice and South End Community in understanding the Project. Community outreach and participation in this State Environmental Quality Review (SEQR) process provides the Albany Port District Commission, the Town of Bethlehem, and City of Albany with an opportunity to provide information to the Ezra Prentice and South End Community and obtain public input as part of the SEQR process.

Specific objectives of this PPP for the Port of Albany are to:

- Keep the local community informed about the Marmen-Welcon Offshore Wind Tower Manufacturing Project and the associated Draft Supplemental Environmental Impact Statement (DSEIS);
- Ensure the opportunity for open communication with the community throughout the SEQR process;
- Ensure outreach efforts include the neighboring Ezra Prentice and South End Community; and
- Create opportunities for the Ezra Prentice and South End Community to be informed and to contribute information and perspectives on the Project and Supplemental EIS process and SDEIS report.

In order to achieve the aforementioned objectives, this PPP provides information regarding the following: (1) Marmen-Welcon Offshore Wind Tower Manufacturing Project; (2) details regarding the process for identification of stakeholders; (3) meaningful opportunities for the Ezra Prentice and South End Community to be informed and to provide input; (4) availability of written information for the public; (5) document repository; and, (6) the manner in which the Albany Port District Commission will report the results of its community outreach activities to the Town of Bethlehem Planning Board and City of Albany Planning Commission.

A Contact List (Appendix A) has been prepared to assist in providing information to area residents, elected officials, and other interested parties who want to be kept informed about the status of the Project and the Supplemental Draft Environmental Impact Statement (SDEIS) process. ### 2. PROJECT BACKGROUND

The Project Site is located on the east side of River Road/Route 144 along the Hudson River at approximately Hudson River Mile 142 (HRM 142) and consists of 81.62 acres. The Project Site is located immediately north and south of the Hudson River's confluence with the Normans Kill in the Town of Bethlehem, Albany County, New York. The Project Site includes a 4.794-acre parcel of land (Tax Map No. 98.01-2-10) along the west side of South Port Road and a 76.825-acre parcel (Tax Map No. 98.00-2-10.23) south of the Normans Kill. The site has two existing and one proposed easement. One existing easement approximately 1.3 acres, located at the southwest corner of the property provided by National Grid for crossing rights to connect the property to River Road/NYS Route 144. The second existing easement is approximately 0.4 acre and is located along the west side of the property and is also provided by National Grid and connects the property to River Road/NYS Route 144 for utility crossings.

The main parcel (Tax Map No. 98.00-2-10.23), known as "Beacon Island", is bound by the following properties:

- To the North: various industrial and warehouse facilities
- To the South: Public Service Enterprise Group Power New York Power Plant (PSEG)
- To the East: Hudson River
- To the West: National Grid overhead electric and natural gas line transmission corridor

A Generic Environmental Impact Statement (GEIS) was prepared by the APDC and approved on June 05, 2020, which analyzed and evaluated potential environmental impacts equally with social and economic factors associated to the conceptual development of the Project. The Project evaluated in the 2020 Final GEIS (FGEIS) included the following elements:

- +/- 1.13 million square feet of industrial space located on the APDC 81.6-acre expansion property, located in the Town of Bethlehem, with maximum building height of 85 feet
- Site infrastructure and utilities associated to the proposed development (e.g., stormwater, sanitary, communications, etc.)
- +/- 1,200 linear foot (LF) wharf and dredging
- bridge over the Normans Kill
- offsite road improvements for site access

The FGEIS Findings Statement established thresholds under the State Environmental Quality Review Act (SEQRA) to be followed during the design phase of the Project. However, if the Project exceeds the establish thresholds or includes additional elements that were not contemplated as part of the FGEIS, a Supplemental EIS is necessary to update or evaluate additional potential environmental impacts not previously evaluated. Now that the Project has been further defined, a Draft Supplemental Environmental Impact Statement (DSEIS) has been prepared by the APDC to identify, evaluate or update foreseeable potential environmental impacts, as applicable.

## **Project Description**

The proposed project is the Marmen-Welcon tower manufacturing plant consisting of 562,000 +/-square feet spread out over five (5) separate buildings. The following is a breakdown of the function and size of each building:

- Building A Plate Preparation & Welding (289,670 SFSF)
- Building B Welding Finishing (74,193 SFSF)
- Building C Blast Metallization Plant (119,841 SF)
- Building D Internal Assembly finishing (57,814 SF)
- Building E Material receiving (19,600 SF)

Tower production will occur within four (4) buildings (Buildings A-D) located on the Port Expansion property located in the Town of Bethlehem. The 5th building (Building E) is located at 700 Smith Boulevard within the existing Port District in the City of Albany. The proposed gated bridge over the Normans Kill will provide trucking transportation in and out of the main facility, by connecting Beacon Island and the 14.7-acre parcel at 700 Smith Boulevard. As shown on the concept plan, employee parking will be situated on the adjoining land owned by National Grid with access from River Road. The proposed wharf and associated dredging along the Hudson River is now limited to approximately 500 linear feet. The wharf will be used to ship completed tower sections.

The Project facility is expected to employ up to 550 full time workers.

Below are the following Project components that either exceed the thresholds established in the FGEIS or that were otherwise not included in the original evaluation.

- Development of 19,600 SF at 700 Smith Boulevard
- Disturbance of 4.4 acres on National Grid Parcel for 2.5 acre employee parking lot
- Increased maximum building height from 85 feet to 100 feet
- Impacts to submerged aquatic vegetation (SAV)
- Update to wetland impacts previously discussed in the 2020 FGEIS

Additionally, Marmen – Welcon commissioned an Air Emissions Analysis performed by Proactive Environmental Solutions to evaluate facility wide potential emissions from both transient activities and mobile sources (construction activities and truck traffic) and stationary sources.




Figure 1.3 Air Emissions Analysis Study Area

To evaluate whether project-related GHG emissions and co-pollutants have the potential to disproportionately burden disadvantaged communities, potential air quality impacts from project emission sources on the nearby EJ Area are compared to other off-property locations surrounding the project. Air dispersion modeling was performed using AERMOD pursuant NYSDEC DAR-1 and DAR-10 guidance. The DEC typically requires a study area of 0.5 mile radius around the proposed facility, however, the study area included the Ezra Prentice community which is approximately 1.7 miles from the production site, and the analysis covered a 5km radius, therefore exceeding the minimum requirement. See figure 1.3 for limits of study area.

The results of the air analysis concludes that the project's impact on air quality in the surrounding community will be below standards and guidelines established by EPA and DEC and that the

project's potential emissions for each regulated air pollutant are well below major facility (Title V) thresholds. The facility is therefore eligible to apply for a NYSDEC Air State Facility Permit as a minor facility of regulated air pollutants. The analysis was included as Appendix E2 in the SDEIS.

The purpose of the SDEIS is to identify and describe the changes in the potential areas of environmental impact from the 2020 FGEIS prepared by the APDC in connection to the Port Expansion Project and continue serving as a guide to demonstrate that the Project is in compliance with SEQRA regulations, and it can be used as the basis for preparing a findings statement and establishing a SEQRA determination.

The SDEIS was submitted to the Town of Bethlehem Planning Board in July 2021 for review, and again in October 2021 to address comments received, and is pending approval.

## 3. COMMUNITY OUTREACH & PARTICIPATION ACTIVITIES

The Albany Port District Commission is committed to informing and involving the Ezra Prentice and South End Community in the development of the Port of Albany - Marmen-Welcon offshore wind project. Community outreach will provide the Ezra Prentice and South End Community with specific information regarding the proposed Project and the contents of the SDEIS and encourage their feedback.

In this spirit, the leadership team at the Albany Port District Commission has worked to collaborate with a variety of stakeholders representing interests in the South End of the City of Albany; including but not limited to AVillage, the South End Improvement Corporation and the Community Collaborative, the Albany Housing Authority & Ezra Prentice Homes, the South Campus Center/Capital Region BOCES, the WAGE Center and the City of Albany Departments, including Youth and Workforce Services and Planning and Sustainability. The goals have been to have open communications, to collaborate on initiatives that would benefit the area and to try to tap into future investments and employment opportunities.

During the Port's application development process for NYSERDA's offshore wind procurement and the Port Infrastructure Investment Program, the APDC team sought to include South End opportunities, as well as development concepts that would work in harmony with the surrounding area. Additionally the Port team sought to have open communication and collaboration. To demonstrate these efforts we provide the following meetings and discussions that have occurred since June 2020.

## 3.2 Publication of Notice in Newspaper

Public notices for the Project will be posted in the legal section of the Albany Times Union. In addition, those parties on the contact list (Appendix A) will be notified of the upcoming issuance of the SDEIS through a mailer notice sent in advance of the publication. The mailer will be sent via regular mail to the stakeholder list and via email to those who have email addresses on the contact list.

## 3.3 Public Information Meetings

In addition to the updates at other South End Community meetings, A dedicated Public Information meetings will be held to provide the community with an opportunity to ask questions on the proposed Project. The meetings will be held in the South End and the members of the Community have recommended the meeting take place at the Salvation Army, Campus of Hope location at 20 S Ferry Street, Albany NY 12202. Alternative locations considered have been at the Ezra Prentice Homes Community Room. The meeting will be held from 5:30 PM to 8 PM or until all participants have had an opportunity to speak.

The project's public community meeting will be held between November 22, 2021 and December 16, 2021 (specific date TBD) after the SEIS has been approved and is open for public comment. This time and location will be determined through coordination with the Salvation Army and members of the South End community and ultimately timing will be based on Town Planning Board action on approving the Public Hearing process. A lot of consideration has been made on how best to accommodate this public meeting to welcome community members and provide project updates. In light of COVID and many South End Community meetings occurring virtually, the Port team solicited input from the community related to locations. The Project team had coordinated with the Albany Housing Authority and made observations from attending the NYSDEC public presentations held for the Ezra Prentice community in 2020. It was observed that all or the majority of residents attended the early evening presentation. The location will be chosen for its ability to accommodate a large audience comfortably with plenty of space, its proximity to the Ezra Prentice community, ADA accessible and has pedestrians, motor vehicles, and public transportation accommodations on a CDTA bus route.

The Port is proposing one dedicated meeting on this as a public session and will present at other existing and established community meetings to provide up to date project information and opportunities to discuss. This includes meetings that occur at different days and times of the day, to provide across the board connection. These meetings also allow for additional in person and virtual opportunity to meet.

Notice of meeting locations, dates, and times will be provided in flyer form in a direct mail piece mailed to resident's homes and emailed to those who have provided email addresses. The meeting



will include a public hearing format where the Port presents the Marmen- Welcon Project as described in the SDEIS and allows the community to provide input and asks questions.





Figure 1.4 Building Photo Simulation Renderings








