ALBANY PORT DISTRICT COMMISSION MINUTES OF THE GOVERNANCE COMMITTEE MEETING NOVEMBER 29, 2023

Chairperson Tagliento called the meeting to order. In attendance were Commissioners Steffens, Coffey, Cinquanti, Tagliento and Abriel. Also present were CEO Hendrick, General Counsel Jordan, CCO Daly, CFO Stuto, DSI Schneidawin, DEA Vavura, SCM Yagan, Director of Security Stock, Administrative Assistant DiLillo and Bill Ring, Logistec General Manager.

Counsel Jordan introduced the minutes of the January 30, 2023 Governance Committee meeting and asked for a motion to approve the minutes. A motion was made by Commissioner Coffey, seconded by Commissioner Cinquanti and passed unanimously.

REVIEW OF COMMITTEE CHARTER

Counsel Jordan presented the Governance Committee Charter. He informed the Committee that management recommended no changes. The Committee reviewed the charter and concurred with management's recommendation and approved the Committee Charter as presented.

REVIEW OF THE MISSION STATEMENT

Counsel Jordan presented the Mission Statement. He noted that the NYS Authorities Budget Office guideline requires that the mission statement be reviewed annually and accepted by the Board. He also mentioned that the ABO recommends that the yearly captures of rental space square footage be included with the mission statement as well. The Board reviewed the Mission Statement and accepted as presented.

Counsel Jordan presented a proposed schedule for the 2024 APDC Board and Committee meetings. He noted that this schedule was for review and that changes could possibly be made throughout the year.
